

Competition T&Cs

1. The Promoter is Parr's Heat Pump Centre, 87 009 529 417, 41 Lampton Avenue, Derwent Park.
2. Information on how to enter and eligibility to be entered into the draw and prize details form part of the conditions.
3. The competition opens on September 21st, 2026, at 12am and closes on December 24th, 2026, at 11:59pm ("Promotion Period").
4. Eligible Participants will be entitled to one draw entry per quote booked.
